**APPLICATION INSTRUCTIONS**

**Postmark /email deadline is March 12, 2010.** Each entrant must submit the following:

1. Completed application form. Mail to **25th Annual ArtFest, Northwest Museum of Arts & Culture**, 2316 W First Ave., Spokane, WA 99201-5906.
2. \$15.00 jury fee. Check or money order payable to the **MAC Foundation**. Email applications will be considered when jury fee is received.
3. An email or CD with five jpeg images representing the work to be exhibited. Send to [artfest@northwestmuseum.org](mailto:artfest@northwestmuseum.org)
4. Jpegs must be a minimum of 4 x 6 inches at 300 pixels per square inch. Generally images between 300 KB and one full MB are satisfactory. Slides or photographs are not accepted. Please match the image number to the “Image Listing” on this page.

Jury notification will be no later than **April 9, 2010**. Detailed information regarding *ArtFest* will accompany notification of accepted artists. Following acceptance, *ArtFest* registration materials must be postmarked no later than **April 30, 2010** and be accompanied by the appropriate fees (see below). The jury will select artists as well as two alternates in each category from submitted images. Invited artists will be allowed to exhibit only the body of work accepted by the jury. Adherence to this requirement will be strictly monitored during the festival by ArtFest committee members. Artists’ booth structures must fit within the confines of the designated space; no part, including tent cords, can extend past these boundaries.

**RESTRICTIONS**

All artwork must be original from concept through completion. No commercial production (such as commercial bisque ware) or student work will be accepted. Reproductions may not constitute more than 10% of the total work shown, and the originals of the reproduction must be exhibited. Reproductions must be clearly labeled as such for *ArtFest* patrons. This does **not** mean that artists may reproduce their artwork on magnets, calendars, mouse pads, etc. and sell them at *ArtFest*. If any commercially made parts are utilized, they must constitute only a small percentage of each piece. We encourage artists to be present. Artist’s partners are acceptable; however, agents and dealers are not allowed. All restrictions will be enforced by the *ArtFest* Committee.

**FEES**

- Non refundable Jury Fee \$15, Due **March 12, 2010**
- Non refundable Entry Fee \$350, Due upon acceptance, **April 30, 2010**. There are no commissioned sales.
- Non refundable Booth Fee \$50 (for 10’x10’) \$60 (for 10’x15’)
- Non refundable \$25 additional Corner Booth Request Fee for either booth size
- Non refundable Electric Fee \$25 (if needed) Due upon acceptance, **April 30, 2010**. First come, first served.
