

DOWNTOWN SPOKANE HOLIDAY WINDOW DISPLAY  
SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Promotion Description: The Spokesman Review Window Display Contest Sweepstakes (“Sweepstakes”) begins on November 24, 2018 at 8:00 a.m. Pacific Time (“PT”) and ends on December 19, 2018 at 4:59 p.m. PT (the “Promotion Period”). By participating in the Sweepstakes, each entrant (or his or her parent or legal guardian if the entrant is under the majority in their home state) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Downtown Spokane Partnership (“Sponsor”), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of sweepstakes entries (“Entries”) and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes.

Eligibility: Open only to legal residents of the United States (excluding Florida) and the District of Columbia. Entrants under the age of the majority in their state of residence must get permission from parents or guardians to enter the Sweepstakes. Void in Puerto Rico, Guam, the U.S. Virgin Islands, and where prohibited or restricted by law. Sponsor, Downtown Spokane Partnership, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (collectively, the “Promotion Entities”), and members of their immediate families and/or persons living in the same household as such persons, are ineligible to enter the Sweepstakes or win a prize.

How to enter: Enter the Sweepstakes during the Promotion Period by completing the voting ballot, selecting a preferred “best window” from among the participating businesses and returning the ballot to the ballot box located inside the Davenport Grant Hotel, 333 W Spokane Falls Blvd, Spokane, WA 99201, entries may be mailed to SPOKESMAN REVIEW WINDOW DISPLAY CONTEST SWEEPSTAKES c/o Downtown Spokane Partnership, 10 N Post Street, #400, Spokane, WA 99201 and must be postmarked by December 19, 2018. Entrants will be asked to provide information including first and last name, email address, and phone number (collectively, “Entry Information”). Limit one (1) entry per person. Additional entries will be disregarded. All entries must be posted by the end of the Promotion Period in order to participate. Sponsor’s database clock will be the official time keeper for this Sweepstakes.

Privacy: All entrants acknowledge that if they are chosen as a winner, certain of their personally identifying information may be disclosed to third parties at least as required by law, including, without limitation, on a winner’s list. All personal information submitted as part of the Sweepstakes may be shared by and between the Promotion Entities, and each of the Promotion Entities will use such information in accordance with their respective independent online privacy policies.

Winner Selection: The winner of the Sweepstakes will be selected in a random drawing from among all eligible Entries received throughout the Promotion Period. The random drawing will be conducted on or about December 20, 2018 by Sponsor or its designated representatives, whose decisions regarding all aspects of Sweepstakes are final. Odds of winning will vary depending on the number of eligible Entries received. Winner will be notified by email on or about five (5) days after the random drawing. Potential winner must accept a prize by either email or telephone as directed by Sponsor within three (3) business

days of notification. Any winner notification not responded to or returned as undeliverable may result in prize forfeiture and an alternate winner shall be selected from among the remaining eligible Entries. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively, the "Prize Claim Documents"). If a winner is not of legal age of majority in his or her state of residence (a "minor"), at Sponsor's option, the applicable prize either will be awarded to the minor or the minor's parent or legal guardian. Such parent or legal guardian of a minor will be required to ratify and sign the Prize Claim Documents. If a winner (or such winner's parent or legal guardian) does not return completed Prize Claim Documents within five (5) days of receipt (or a shorter time if required by exigencies), the winner may be disqualified and an alternate winner may be selected from the remaining eligible entrants.
