

DOWNTOWN SPOKANE
SMALL BUSINESS BINGO
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Promotion Description: Downtown Spokane Small Business Bingo (“Bingo”) begins on November 28, 2020 at 8:00a.m. Pacific Time (“PT”) and ends on December 21, 2020 at 8:00 p.m. Pacific Time (“PT”) (the “Promotion Period”). By participating in Bingo, each entrant (or his or her parent or legal guardian if the entrant is under the majority in their home state) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Downtown Spokane Partnership (“Sponsor”), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Bingo entries (“Entries”) and the overall administration of Bingo. Entrants should look solely to Sponsor with any questions, comments or problems related to Bingo.

Eligibility: Open only to legal residents of the United States and the District of Columbia. Entrants under the age of the majority in their state of residence must get permission from parents or guardians to enter Bingo. Void in Puerto Rico, Guam, the U.S. Virgin Islands, and where prohibited or restricted by law. Sponsor and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (collectively, the “Promotion Entitys”), and members of their immediate families and/or persons living in the same household as such persons, are ineligible to enter Bingo or win a prize.

How to enter: Enter Bingo during the Promotion Period by downloading and printing Bingo Cards from downtownspokane.org, or collecting a Bingo Card at Wheatland Bank at 222 N. Wall St. #100. Completed cards should be turned in at Wheatland Bank at 222 N. Wall St., #100 to a designated drop box. Entrants will be asked to provide information including first and last name, email address, and phone number (collectively, “Entry Information”). Limit one (1) entry per person. Additional entries will be disregarded. All entries must be turned in by the end of the Promotion Period in order to participate. Completed Bingo cards will only be eligible if the participant has collected a stamp or signature from five participating businesses in a row, column, or diagonally (corner to corner) on a Bingo card. Stamps or signatures must have been collected from the same business that corresponds to its respective Bingo square.

Privacy: All entrants acknowledge that if they are chosen as a winner, certain of their personally identifying information may be disclosed to third parties at least as required by law, including, without limitation, on a winner’s list. All personal information submitted as part of Bingo may be shared by and between the Promotion Entities, and each of the Promotion Entities will use such information in accordance with their respective independent online privacy policies.

Winner Selection: Winners of Bingo will be selected in a random drawing from among all eligible Entries received throughout the Promotion Period. Four random drawings will be conducted on Nov. 30, Dec. 7, Dec. 14, and Dec. 21 by Sponsor or its designated representatives, whose decisions regarding all aspects of Bingo are final. Odds of winning will vary depending on the number of eligible Entries received. Winners will be notified by email or phone on or about five (5) days after the random drawing. Potential winner must accept a prize by either email or telephone as directed by Sponsor within three (3) business

days of notification. Any winner notification not responded to or returned as undeliverable may result in prize forfeiture and an alternate winner shall be selected from among the remaining eligible Entries. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively, the "Prize Claim Documents"). If a winner is not of legal age of majority in his or her state of residence (a "minor"), at Sponsor's option, the applicable prize either will be awarded to the minor or the minor's parent or legal guardian. Such parent or legal guardian of a minor will be required to ratify and sign the Prize Claim Documents. If a winner (or such winner's parent or legal guardian) does not return completed Prize Claim Documents within five (5) days of receipt (or a shorter time if required by exigencies), the winner may be disqualified and an alternate winner may be selected from the remaining eligible entrants. No substitution or transfer of a prize is permitted except by Sponsor. Federal, state and local taxes, if any are the responsibility of the winner or parent/legal guardian of a minor.

Prizes: Upon each random drawing, one winner will be selected to win \$500 cash. If an eligible entry is not selected as a winner, that entry remains eligible for any ensuing random drawings on the aforementioned dates. If, at the end of the Promotion Period, a participant has successfully collected stamps or signatures on all 25 squares of a given Bingo card from the respective business corresponding to each square, that entry will be automatically awarded a \$10 gift card or certificate of \$10 value to the business of the participant's choice within the Spokane Business Improvement District. Selected businesses must be a Ratepayer and in good standing with the Downtown Spokane Partnership. Sponsor retains the right to deny a winner's choice of business and will allow them to select an approved business if a winner's choice is not deemed eligible.

Only one (1) prize per person and per household will be awarded. Prizes cannot be transferred, redeemed for cash or substituted by winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. If the actual value of the prize turns out to be less than the stated value, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not replace any lost or stolen prize items.

General Conditions: Entrant agrees that decisions regarding Bingo made by the Sponsor or its designated agents is final, and: a) any and all disputes, claims, and causes of action arising out of or connected with Bingo, or any prize awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in a federal or state court located in the State of Washington; entrant submits to sole and exclusive personal jurisdiction to said courts in the State of Washington, for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; b) any and all claims, judgments, and awards shall be limited to actual out of pocket costs incurred, including costs associated with entering Bingo but in no event attorneys' fees; and c) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.**

Prize will only be awarded and/or delivered to addresses within the United States. All federal, state and/or local taxes, fees, and surcharges are the sole responsibility of the prize winner. Failure to comply with the Official Rules will result in forfeiture of the prize. If prize is forfeited, an additional drawing at random from eligible Entries may be made to determine a winner.

Except where prohibited by law, the winner (and parent/legal guardian if winner is a minor) grants (and agrees to confirm that grant in writing) permission for the Promotion Entities, their advertising and promotional agencies, and those acting under its authority to use such winner's name, photograph, voice and/or likeness, for advertising and/or publicity purposes in all media now known or hereafter discovered, worldwide and on the world wide web, without notice, review, approval, or additional compensation.

Release of Liability: By acceptance of a prize, winner agrees that the Promotion Entities will have no liability whatsoever for, and shall be held harmless by winner (and parent/legal guardian if entrant is a minor) against, any and all liability for injuries, loss or damage of any kind to persons, including death, or property damage resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize, participation in this promotion, or while traveling to, preparing for or participating in any Bingo-related activity. The Promotion Entities expressly disclaim any responsibility or liability for injury or loss to any person or property in connection with the prizes awarded.

Conduct: Sponsor reserves the right at its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operations to any of Bingo; to be acting in violation of the Official Rules; or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. CAUTION: ANY DELIBERATE ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF BINGO IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

Limitation of Liability: Sponsor is not responsible for any incorrect or inaccurate information. If, for any reason, Bingo is not capable of running as planned then Sponsor reserves the right in its sole discretion to cancel, terminate, modify or suspend Bingo. In such event, Sponsor may, in its sole discretion, perform the random drawing from among all eligible Entries received prior to or after such cancellation, suspension, or modification.
