**1. Eligibility:**

The Sky Walk Challenge Sweepstakes ("Sweepstakes") is open to legal residents of the State of Washington who are 18 years of age or older at the time of entry. Employees, officers, and directors of Downtown Spokane Partnership ("Sponsor"), its affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members are not eligible to participate.

**2. Sweepstakes Period:**

The Sweepstakes begins at 12:00 AM PT on July 4, 2024, and ends at 11:59 PM PT on July 18, 2024 ("Sweepstakes Period").

**3. How to Enter:**

Scan a QR code provided at designated locations to access an online scavenger hunt worksheet.

All questions must be answered correctly to be entered into the drawing. This includes providing contact information.

Entrants may only complete the quiz one time. Three quiz worksheets are available in different skywalks.

Participants have from midnight on July 4 until 11:59 p.m. on July 18 to submit their completed quiz.

Limit one entry per person. Multiple entries will be disqualified.

**4. Grand Prize Drawing:**

A random drawing will be conducted on July 19, 2024, from all eligible entries received during the Sweepstakes Period. Odds of winning depend on the number of eligible entries received.

**5. Prizes:**

Grand Prize: \$500

Runner-Up Prizes: 5 runner-up prizes of \$50 each

Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion.

#### **6. Winner Notification:**

Winners will be notified by email or phone within five (5) days following the drawing. The Grand Prize winner will be required to sign and return an affidavit of eligibility, release of liability, and a publicity release (except where prohibited) within seven (7) days of notification.
