

**KIDS HOLIDAY HUNT
FAMILY PRIZE PACK
SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Promotion Description:

The Kids Holiday Hunt (“Sweepstakes”) begins on November 29, 2024 at 8:00 a.m. Pacific Time (“PT”) and ends on December 22, 2024 at 7:59 p.m. PT (the “Promotion Period”). By participating in the Sweepstakes, each entrant (or their parent or legal guardian if the entrant is under the age of majority in their home state) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Downtown Spokane Partnership (“Sponsor”), which shall be final and binding in all respects. The Sponsor is responsible for the collection, submission, or processing of sweepstakes entries (“Entries”) and the overall administration of the Sweepstakes. Entrants should direct any questions, comments, or problems related to the Sweepstakes to the Sponsor.

Eligibility:

The Sweepstakes is open only to legal residents of the United States (excluding Florida) and the District of Columbia who are 12 years of age or younger, with the permission of a parent or guardian 17 years of age or older. Entrants under the age of majority in their state of residence must have permission from a parent or guardian to enter the Sweepstakes. Void in Puerto Rico, Guam, the U.S. Virgin Islands, and where prohibited or restricted by law. Employees, officers, and directors of the Downtown Spokane Partnership, Sponsor, and their respective parents, subsidiaries, affiliates, distributors, retailers, advertising, and promotion agencies (collectively, the “Promotion Entities”), and members of their immediate families or those living in the same household are ineligible to enter the Sweepstakes or win a prize.

How to Enter:

To enter, participants must locate seven characters hidden inside participating businesses during the Promotion Period by using the provided Holiday Hunt Sticker Passport. The completed Passport must be returned to the mailbox at 818 W Riverside. Mailed entries should be sent to Kids Holiday Hunt c/o Downtown Spokane Partnership, 818 W Riverside, STE 120, Spokane, WA 99201 and must be postmarked by December 22, 2024. Entrants will be asked to provide information, including first and last name, email address, and phone number. Limit one (1) entry per person. All entries must be posted by the end of the Promotion Period to participate. The Sponsor’s database clock will be the official timekeeper for this Sweepstakes.

Privacy:

Entrants acknowledge that if they are chosen as a winner, their personally identifying information may be disclosed to third parties, as required by law, including but not limited to publication on a winner’s list. Personal information collected as part of the Sweepstakes may be shared by and between the Promotion Entities, and each Promotion Entity will use such information according to their respective privacy policies.

Winner Selection:

The winner(s) will be selected via a random drawing from among all eligible Entries received throughout the Promotion Period. The random drawing will be conducted on or about December 23, 2024 by the Sponsor or its designated representatives, whose decisions regarding all aspects of the Sweepstakes are

final. The odds of winning vary depending on the number of eligible Entries received. Winners will be notified by email on or about three (3) days after the random drawing. The potential winner must accept the prize by email or telephone as directed by the Sponsor within ten (10) business days of notification. If a prize notification is not responded to or is returned as undeliverable, the prize may be forfeited and an alternate winner selected from the remaining eligible Entries.

Prizes:

Three (3) Grand Prize winners will receive a combination of items, including but not limited to:

- Gift cards
- Tickets and passes for local attractions
- Family activity packages

Only one (1) prize per person or household will be awarded. Prizes cannot be transferred, redeemed for cash, or substituted, except at the Sponsor's sole discretion. The Sponsor reserves the right to substitute a prize of equal or greater value if any part of the prize becomes unavailable.

General Conditions:

By entering the Sweepstakes, entrants agree to abide by the Sponsor's decisions, which are final, and:

- a) Any disputes arising out of or related to this Sweepstakes will be resolved individually, in Washington state courts, without resort to class actions.
- b) Damages will be limited to actual out-of-pocket costs, and entrants waive the right to claim punitive damages.
- c) The winner (or their parent/legal guardian if the winner is a minor) grants permission to the Promotion Entities to use their name, image, voice, and likeness for publicity purposes without additional compensation, unless prohibited by law.

Limitation of Liability:

Sponsor is not responsible for incorrect or inaccurate information or any technical issues that may affect the Sweepstakes' operation. The Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes if it is not capable of running as planned, including due to fraud or technical failures.
