

## **SHOW UP FOR DOWNTOWN SCAVENGER HUNT SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.**

### **Promotion Description:**

The *Show Up for Downtown Scavenger Hunt* Sweepstakes (“Sweepstakes”) begins on August 22, 2025, at 3:00 p.m. Pacific Time (“PT”) and ends on August 22, 2025, at 7:00 p.m. PT (the “Promotion Period”). By participating, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Downtown Spokane Partnership (“Sponsor”), which shall be final and binding in all respects. The Sponsor is responsible for the collection, submission, or processing of entries (“Entries”) and the overall administration of the Sweepstakes. Entrants should direct any questions, comments, or problems related to the Sweepstakes to the Sponsor.

### **Eligibility:**

The Sweepstakes is open only to legal residents of the United States (excluding Florida) and the District of Columbia who are 18 years of age or older. Void in Puerto Rico, Guam, the U.S. Virgin Islands, and where prohibited or restricted by law. Employees, officers, and directors of the Downtown Spokane Partnership, Sponsor, and their respective parents, subsidiaries, affiliates, distributors, retailers, advertising, and promotion agencies (collectively, the “Promotion Entities”), and members of their immediate families or those living in the same household are ineligible to enter or win.

### **How to Enter:**

To enter, participants must follow the event clues and complete the official worksheet during the Promotion Period. Completed worksheets must be submitted by 7:00 p.m. PT on August 22, 2025, at the designated drop-off location: 818 W Riverside, Spokane, WA 99201. Entrants will be asked to provide their name, email address, and phone number. Limit one (1) entry per person. All entries must be received by the end of the Promotion Period to be eligible. The Sponsor’s database clock will be the official timekeeper for this Sweepstakes.

### **Privacy:**

Entrants acknowledge that if they are chosen as a winner, their personally identifying information may be disclosed to third parties, as required by law, including but not limited to publication on a winner’s list. Personal information collected as part of the Sweepstakes may be shared by and between the Promotion Entities, and each Promotion Entity will use such information according to their respective privacy policies.

### **Winner Selection:**

The winner will be selected via random drawing from among all eligible Entries received during the Promotion Period. The drawing will be conducted on or about August 22, 2025, 7:30pm PST by the Sponsor or its designated representatives, whose decisions regarding all aspects of the Sweepstakes are final. Odds of winning depend on the number of eligible Entries received. The winner will be notified by email or phone on or about three (3) business days after the drawing. The potential winner must accept the prize by email or telephone as directed by the Sponsor within ten (10) business days of notification. If a prize notification is not responded to or is returned as undeliverable, the prize may be forfeited and an alternate winner selected.
