## DOWNTOWN SPOKANE STCU WINDOW DISPLAY CONTEST SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Promotion Description: The STCU Window Display Contest Sweepstakes ("Sweepstakes") begins on December 1, 2022 at 8:00 a.m. Pacific Time ("PT") and ends on December 18, 2022 at 9:59 p.m. PT (the "Promotion Period"). By participating in the Sweepstakes, each entrant (or his or her parent or legal guardian if the entrant is under the majority in their home state) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Downtown Spokane Partnership ("Sponsor"), which shall be final and binding in all respects.
